

# Personal Information Collection Statement

---

## 1. OUTLINE

1.1 This Personal Information Collection Statement, which is subject to the Privacy Act and our Privacy Policy, is intended to notify you about the collection of your *personal information* by us for the purpose of carrying on one or more of our functions as set out at clause 2. This Personal Information Collection Statement covers all matters required to be covered under APP 5 in relation to the notification of the collection of your *personal information*.

## 2. PURPOSE

2.1 **Primary and Secondary Purposes.** We collect your *personal information* to lawfully carry out our functions and activities including to:

- a) process and deliver Products and Services to you;
- b) provide you with information about the Products and Services you requested or inquired about;
- c) personalise and customise your experiences with us;
- d) help us meet our warranty obligations;
- e) help us assess an application submitted by you or on your behalf in relation to your employment with PRO ALI Design;
- f) help us review, manage and enhance our Products and Services and develop insights used in reports or other content developed by us;
- g) communicate with you, including by email, mobile and in-application notifications;
- h) to process payments and administer your account, including to send you account related reminders;
- i) investigate any complaints about or made by you, or if we have reason to suspect you have breached any relevant terms; or
- j) as required or permitted by any law.

2.2 Further information about our purposes for collecting your *personal information* can be found in our Privacy Policy.

## 3. WHAT WE COLLECT

3.1 *Personal information* we collect about you may include identification information such as your name, address, email address, phone number(s), financial and payment information and such other information necessary or convenient for delivering our Products and Services. We also may collect additional information as part of our collection of Identity, Contact, Financial, Transaction, Technical, Marketing and Communications, Client and Profile information used for the Primary and Secondary Purposes.

3.2 We typically only collect *personal information* about you from you. However, if we collect *personal information* about you from some one other than you, and it would not be reasonable for you to expect us to have collected that *personal information*, we will take reasonable steps to ensure that you are made aware that we have collected the relevant *personal information*.

3.3 We will only collect, store, use or disclose your *sensitive information* with your consent.

## 4. FAILURE TO COLLECT INFORMATION

4.1 **Consequences.** If you do not provide us with the *personal information* we request, or if that information is incomplete or inaccurate, we may not be able to provide our Products and Services to you.

## 5. DISCLOSURE

5.1 **How we disclose.** We may disclose *personal information* and you consent to us disclosing such *personal information* to:

- a) third parties engaged by us to perform functions or provide Products and Services on our behalf;
- b) relevant regulatory bodies in the industry in which we or you operate;
- c) our professional advisors, including our accountants, auditors and lawyers;
- d) persons authorised by you to receive information held by us, including to those individuals that you authorise us to provide information to via the Platform;
- e) a government authority, law enforcement agency, pursuant to a court order or as otherwise required by law; or
- f) a party to a transaction involving the sale of our business or its assets.

## 6. OVERSEAS DISCLOSURE

6.1 We do not disclose *personal information* to overseas recipients for any reason.

6.2 You acknowledge and agree that you have read and agree to the terms of our Privacy Policy in relation to the disclosure of your *personal information* to overseas recipients.

## 7. PRIVACY POLICY

7.1 Our Privacy Policy contains further details concerning:

9.1 **Personal pronouns:** Except where the context otherwise provides or requires:

- a) the terms **we**, **us** or **our** refers to PRO Design; and
- b) the terms **you** or **your** refers to a user of the Platform and/or a customer to whom we provide the Products and Services.

9.2 Terms italicised and defined in the Privacy Act have the meaning given to them in the Privacy Act.
